#### **UPDATE ON THE ROCK ISLAND TRAIL:**

#### Here's what's reported on the Jackson Co website:

The website continues to say that phase 2 of the Rock Island trail is still on schedule to be completed in early 2021 – it sure seems like it's taking forever! Here's an update from their website:

The new section of the trail will include trailheads at Truman Sports Complex, Downtown Raytown and Woodson Road. There will also be an unofficial trailhead at the Raytown Chamber of Commerce which was built by the Chamber. Trailheads will include historical signage to tell the story of the old railroad and its impact on the community. The Raytown trailhead will also have an old "bumping post", a relic left behind by the old railroad.

New pedestrian bridges will be placed from the sports complex to 63<sup>rd</sup> Street. The old bridges will be available to Kansas City Area Transportation Authority for their transit project. Existing bridges will be used south of 63<sup>rd</sup> with the exception of the Wildwood Bridge, because that bridge has deteriorated beyond a useful life.

The trail will be off of the railbed from the sports complex to Woodson by at least 25 feet and mainly on the railbed south of Woodson. This is due to KCATA's anticipated transit project.

The 6.4 mile first phase of the trail was completed in June 2019. It starts at Brickyard Road and travels south through Lee's Summit to Jefferson Street. When phase two is finished it will complete the 13.5 mile trail.

Rock Island Project Manager Matt Davis said the long term goal is to connect the Rock Island Trail to the 240 mile long Katy trail.

There is an eight mile gap between the two trails he said. "We have funding for an additional 1.3 miles that will be constructed during 2021-2022. We will apply for federal funding for 2023-2024, that would get us another 1.5 miles and into Greenwood. We will likely continue to take this phased, multi-year approach as funding is our biggest challenge."

## **NATURE HIGHLIGHT – "POKEBERRIES"**

**Pokeberries** are found in grape-like clusters on tall perennials with purple-red stems. Eating several berries can cause pain, nausea, vomiting, and diarrhea.

As I was walking along the new (not quite finished) trail, I noticed a number of ripe pokeberries. The bushes pop up in my garden bed regularly. I remember my father (a physician) telling a neighbor that they were poisonous, causing internal bleeding, but her child probably wasn't hurt if he only ate a few.

Phytolacca americana, also known as American pokeweed, poke sallet, or dragonberries is a native poisonous perennial bush growing up to 8 foot high. It can be identified by its green to red-purple stems and a thick white taproot. The flowers are green to white, followed by purple-black berries which are a good food source for songbirds but are toxic to dogs, humans and horses. Opossums, racoons and foxes may be tolerant of the toxins. The seeds have long viability, able to germinate after many years in the soil. Pokeweed has been grown as an ornamental plant in wildlife gardens, mainly for its attractive berries and because it does draw the berry eating songbirds.

In the past, pokeweed was sometimes used in herbal remedies or to make a pink dye from the juice of the berries. Despite its toxicity, Poke is also a traditional southern Appalachian food with Poke Salad even celebrated in town festivals. The leaves and stems of young plants can be eaten, but must be cooked by boiling two or more times with the water drained and replaced each time. The leaves taste similar to spinach; the stems, similar to asparagus. The roots cannot be made edible.

All parts of the plant can be toxic and pose risks to human and mammalian health. Toxins are found in highest concentration in the rootstock, then leaves and stems, then the ripe fruit. The plant generally gets more toxic with maturity, with the exception of the berries, which are dangerous even while green. Since the juice of pokeweed can be absorbed through the skin, contact of plant parts with bare skin should be avoided. If you want to eliminate the plant in your garden, it's easier to pull it up when it's young and be sure to dig up as much of the long taproot as you can, and use gloves...
